Annual Education Report (AER) Cover Letter

Dear Parents and Community Members:

We are pleased to present you with the Annual Education Report (AER) which provides key information on the 2021-22 educational progress for South Central Michigan Virtual. The AER addresses the complex reporting information required by federal and some requirements of state laws. Our staff is available to help you understand this information. Please contact Mr. Fred Parker Jr., Director for help if you need assistance.

For the 2021-22 school year, schools were identified based on previous years' performance using definitions and labels as required in the Every Student Succeeds Act (ESSA). A Targeted Support and Improvement (TSI) school is one that had at least one underperforming student subgroup in 2018-19. An Additional Targeted Support (ATS) school is one that had a student subgroup performing at the same level as the lowest 5% of all schools in the state in 2017-18. A Comprehensive Support and Improvement (CSI) school is one whose performance was in the lowest 5% of all schools in the state or had a graduation rate at or below 67% in 2016-17. Some schools are not identified with any of these labels. In these cases, no label is given.

SCMV was identified as Comprehensive Support and Improvement (CSI) in the 2016-2017 school year.

State law requires that we also report additional information:

1. PROCESS FOR ASSIGNING PUPILS TO THE SCHOOL

The South Central Michigan Virtual is the only K-12 virtual program in the Jackson Public School (JPS) District. Students that typically attend South Central Michigan Virtual (SCMV) feel that the traditional classroom isn't an optimal fit for their educational needs. Our student population consists of

homeschooled students, students that desire a more flexible learning environment, and even some students that have experienced some discipline challenges. Students go through an intake and an in-person orientation process as they are being onboarded as a student at SCMV.

2. THE STATUS OF THE 3-5 YEAR SCHOOL IMPROVEMENT PLAN

South Central Michigan Virtual is working to improve upon its virtual course completion rate. In 2021 our course completion was 48%. South Central Michigan Virtual course completion is slightly lagging the statewide average of 56%. We attribute our course completion directly to the impact and lingering effects of Covid-19. We've made a multitude of adjustments to better serve our students in this post-pandemic educational environment. One major pivot that we've made was shifting from in-person tutoring to webinar-based tutoring. This adjustment has helped us serve our students despite the ebb and flow of Covid-19. Additionally, we have worked diligently to re-integrate our students back into our on-site learning lab. We've created subject-specific lab and tutoring sessions to assist students get back on target progress. We are actively working to improve the delivery of our content and the success of our students through success coaching and assigning each struggling student a focus mentor.

3. A BRIEF DESCRIPTION OF EACH SPECIALIZED SCHOOL

SCMV offers over one thousand five hundred courses to its students. From advanced placement courses, world languages, and a myriad of electives. Additionally, SCMV has a dedicated Teacher Consultant along with six resource teachers to support vast offers to our Special Education students.

4. IDENTIFY HOW TO ACCESS A COPY OF THE CORE CURRICULUM, A DESCRIPTION OF ITS IMPLEMENTATION, AND AN EXPLANATION OF THE VARIANCES FROM THE STATE'S MODEL

SCMV utilizes a variety of platform partners that are in line with the State Board of Education's Model Core Curriculum. The curriculum is published through mvu.org and/or is approved by the district school board.

5. THE AGGREGATE STUDENT ACHIEVEMENT RESULTS FOR ANY LOCAL COMPETENCY TESTS OR NATIONALLY NORMED ACHIEVEMENT TESTS

SCMV students participate in the Northwest Evaluation Association (NWEA) Measures of Academic Progress (MAP) during the Fall and Spring in Reading and Math (see table above.) This tool helps assess student growth,

monitoring academic progress over time, and goal setting for each student. Furthermore, SCMV monitors student's pass/completion rates juxtaposing them against statewide virtual pass/completion averages.

South Central Michigan Virtual (SCMV) incorporated Inspect as an assessment tool in 2021. We established a goal to see 25% of students demonstrate growth or progress towards growth for the Michigan ELA standards and 20% in Michigan Math standards. Students achieved 31% in ELA and 24% growth toward progress respectively. We attribute this increase to re-engaging students with our in person learning lab and tutoring.

SCMV has constant two-way communication with its students and parents throughout the year. Students are assigned a success coach or focus coach depending on their performance. Success coaches and Focus coaches communicate weekly with parents regarding the student's progress. Additionally, each student is assigned a lead teacher that communicates regularly with parents and guardians. Moreover, SCMV convened with

parents and students during our in-person orientation meetings to discuss expectations and rubrics for success. As a result of Covid-19, we've added a virtual orientation process as an option to our students and families.

SCMV has 8 students enrolled in our early college program taking 12 classes

SCMV has 10 courses passed, all leading to college credit.
